Construction projects

With the weather picking up, construction has continued. So far, this year they have sealed the foundation, and are beginning the stages of the main structure. The goal is to have the hull of the building and roof, so that it is weatherproof by winter, then continue working on the inside during the winter with the goal to finish by summer of next year. The hull and roof is estimated to cost 4,000-6,000 dollars and probably the interior and furnishing will be at least that much.

The zoning paperwork has been filed and we await completion of that process. (for comparison, the addition we started in 2014 only recently was finalized)



In addition to the church building project, Vova, along with the men and women in the rehab centers, has been renovating the women's rehab center.

There is a possibility that Galina's cancer has returned. She is waiting for results. Her doctor is considering surgery instead of chemotherapy, if that is the case.

In the last newsletter, I mentioned that Eugene's friend, Zhenya, was potentially in some legal trouble. It appears that he is going to be given probation only. Since his baptism in December, he has been giving short communion thoughts and lessons. Recently, he visited Eugene in Kiev, and is considering attending Ukrainian Bible Institute, where Eugene translates. UBI is operated by Sunset International Bible Institute.
